

Vantage Riverstone Seasonal Tenant Information and Application

All prospective tenants must complete this application for verification of employment and/or income. Those approved for tenancy must sign a Seasonal Trailer Site Agreement Lease (Six (6) month limit) and a set of Resort Park Rules.

Due upon move-in includes NON-refundable first month's rent of \$450-\$700, depending on site, last month's rent deposit of same amount, and an electricity deposit of \$100 which may be applied against the last month's utility usage. The second month of rent will be prorated from the date of check-in of second month to the end of the second month, to bring the billing cycle to the first of every month going forward. First month's rent and deposits must be paid by credit card. Remaining monthly rent is due by the 5th of each month. Late fee is \$10.

Seasonal site rental is not to be considered a residence. Vantage Riverstone strictly offers seasonal sites to accommodate workers in the area. Seasonal sites are available to local workers and one immediate family member per site. Seasonal tenancy is for stays from 2-6 months. Rentals longer than 6 months must be under a separate lease rental agreement and must be approved by management. If you are not within the seasonal criteria, management approval is required in advance to be considered for Seasonal Tenancy. A new lease applies for intention to stay at Vantage Riverstone after said six months. Pets are welcome with prior approval on case-to-case basis and subject to breed restrictions.
